6. Electronic bids must be submitted to the office Mandavi Rural Municipality, through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hrs on 2076/09/22. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 2076/09/22 at the office of Mandavi Rural Municipality. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 665,000.00 which shall be valid for 30 days beyond the validity period of the bid (atleast 120 days from bid opening date, fill it yourself).
